General Increase Notice

A general increase of 2.4% of the tariffs currently being used at the Port of Sept-Îles will be applied on January 1st, 2026. This increase is based on Statistics Canada's publication of the Consumer Price Index (CPI) established on an annualized basis at the end of September 2025 ([See the notice by clicking here](#)).

You will find below the tariff revision other than the general increase of 2.4% and the new tariffs that will come into effect.
